#### PROCEEDINGS OF THE GOVERNMENT OF MYSORE.

<u>SUBJECT:-</u> Continuance beyond 30-6-1966 of the four Private Teachers Training Institutions started under the Government of India Scheme of Universal Free and Compulsory Primary Education - Sanctioned.

# PREAMBLE

\_\_\_\_\_

The under-mentioned four Private Teachers' Training Institutions, among others, were sanctioned during 1960-61 in . the first of the Government Orders read above under the programme of expansion of the Teachers' Training facilities with reference to the Government of India Scheme of Universal Free and Compulsory Primary Education by the end of the Third Plan Period. The institutions were to receive grant-in-aid at cent-per-cent of the actual approved expenditure, subject to a limit of Rs.40,000/- per institute of 100 trainees, for recurring expenditure on emoluments of teachers, stipends to trainees, rent of buildings etc.

- 1. Sivamathreswara Basic Training Institute for Men, Mysore.
- 2. Sivarathreswara Basic Training Institute for Women, Mysore.
- Sri Thakkar Bapa Basic Training Institute, Bangalore.
   St.Joseph Convent Basic Training Institute for Women, Mandya.

The above four institutions were ordered to be continued in the Government Order dated 27-5-1961 cited above, beyond 31-3-1961 to end of the Third Five Year Plan period, with the sanctioned recurring provision for each institution.

As per the Government Order's read at Sl.Nos. 3 and 4 above all the posts created under the Plan Scheme which were actually filled in for the successful implementation of the scheme were continued from 1-4-1966 till the end of June 1966.

The Director of Public Instruction in Mysore, Bangalore, recommends that the four Private Teachers' Training Institutions in question be continued with their staff under normal budget. It is proposed that the same net cost, limiting it to Rs.40,000/be given as financial assistance to each of these institutions during 1966-67 only, as from the next year, these institutions have to take their place with the other private teachers' Training Institutions and be eligible for maintenance and other grants as per the uniform grant-in-aid Code which is to be brought into force from the next year.

It is stated that necessary provision has been made under the Budget head "28-Education-D.N.Direct Grants to Non-Government Special Schools - 8 - Opening of New Teacher Training Institutions under introduction of new curriculum etc. for 1966-67",

#### ORDER NO. ED 112 PTI 66, BANGALORE, DATED THE 15TH OCTOBER 196 SAKA ERA 1888.

In the circumstances, it is directed that the above mention four Non-Government Private Teachers' Training Institutions be continued on a permanent basis, and that financial assistance be given for 1966-67 as net cost institutions, limiting the same to each of these institutions to Rs.40,000/- annually, based on the audited figures of 1965-66. These institutions shall rank on a par with the other institutions from the next year 1967-68 for purposes of grant-in-aid as per uniform rules to be brought into force from the next year.

The incidental recurring expenditure authorised at the time of starting the institutions with subsequent amendments, if any, is also sanctioned with effect from 1-4-1966 to end of 31-3-1967.

The expenditure on this account shall be accommodated in the budget provision as proposed, after making the 10% cut ordered in Government Order No.FD 75 BUD 66, dated 12-8-1966.

### ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to **St.Joseph's Teacher Training Institute for Women, Head Post Office, V.V. Road, Mandya-571401, Karnataka** for **Elementary course** of two years duration from the academic session **2000-2001** with an annual intake of **60**, subject to fulfilling the following conditions:

- The institution shall appoint within a period of one year two additional teaching staff possessing the academic qualifications as laid down in the NCTE norms, in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
- All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
- 3. Instructor for Work Experience and Education Technology should be appointed.
- Librarian, Library Asst. and Technical Asst. should be appointed.
- The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
- 6. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University / State Government as the case may be.
- 7. Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government as the case may be till such time NCTE regulations in respect of fee structure come into force.
- Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University / examining body as the case may be.
- Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.

- The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
- 11. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If St.Joseph's Teacher Training Institute for Women, Head Post Office, V.V. Road, Mandya-571401, Karnataka contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfill the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.

PAR for the session 2004-2005 shall be sent to this office on or before 31st August 2005 failing which renewal of recognition for the same will not be considered.
